## A) Why are you applying for this position?

I became an Accredited Member of the AACD in 2018. It took me ten years to become Accredited. I met my mentor at one of the scientific sessions. We began reviewing cases, and he gave me feedback by reviewing the criteria and recommending what I could do to improve the final result. I began to pass cases one by one. I slowly started to believe that I had the skills needed to become Accredited. This experience was life changing. I had been through many challenging situations before, including running two marathons, starting my own practice, supporting my family financially while my husband went through a career change, and overcoming health issues. But somehow getting accredited was always in the back of my mind. I couldn't stop until I reached my goal. The monumental challenge of being awarded Accredited status has made me very proud of the credentialing process. Having the opportunity to serve on the American Board of Cosmetic Dentistry would be an incredible honor. If I could help the Academy continue to provide the Accreditation process to its members, it would be my way of protecting the credential and giving back to the AACD.

## C) Leadership skills and organizational style

In line with the motto "Responsible Esthetics," my practice philosophy is "Conservative Restorative Dentistry." It really pains me to cut healthy tooth structure, and my patients know and appreciate my conservative approach.

At the end of the day, it should be a balance between time-tested conservative principles and the best new ideas with an educated dental provider at the center. The AACD is a champion of conservative care; and the credential provides for a rigorous protocol that separates the best cosmetic dentistry providers from the rest.

In my 22 years of experience as a dentist, I have been a member of many organizations. I have never felt a part of most of those organizations. I paid my dues and at the very most attended conferences. The first time I felt like I belonged to an organization was when I met my mentor Dr. Stephan Orser. He made the time to give me critical feedback about my case submissions. I was humbled by his dedication to the AACD and his generosity. I wish I met him earlier on in my

accreditation journey. If I can reach out to another member in the way my mentor reached out to me, I know I can elevate their professional practice.

As far as the actual Accreditation process, knowing that my work was evaluated and passed has given me confidence clinically and philosophically. I feel I would represent the academy and the credentialing process in a way that it has not been represented before. Many general dentists do not know about the credential, as well as many patients. I would like to see the AACD's presence increase at the university level and in general to the public. I am often explaining to patient's what Accreditation means. I think I can help familiarize and expand our membership base by reaching out to more general dentists.

Lastly, dentistry can be a lonely profession. Feeling like one belongs to a group, whether big or small, certainly helps to make one feel less lonely in their professional journey. I know that when someone from the AACD reaches out to me, I feel more connected to my profession and to the AACD. I think that if members are made to feel more of a part of a close-knit group, it would benefit them in many ways. For example, Dr. Jim Peyton reached out to me after I passed my first case to ask if I would write an article for the JCD regarding my case. It boosted my confidence immensely and I was thrilled that he reached out to me. In the end, I published my first article.
